ADC'S CULTURALLY COMPETENT BUSINESS DEVELOPMENT SERVICES AND ITS PARTNERSHIPS WITH CRUCIAL FUNDING SOURCES HAVE DIRECTLY CONTRIBUTED TO THE SURGE IN AFRICAN-OWNED BUSINESSES THROUGHOUT MINNESOTA. IN ADDITION TO ONGOING TECHNICAL ASSISTANCE, ADC HAS AN ENTREPRENEURIAL TRAINING CLASS FOR CLIENTS LOOKING TO START A COMPLETELY NEW BUSINESS.

ADC MADE 106 LOANS IN 2023 WITH A TOTAL APPROVED LOAN AMOUNT OF \$13,859,546 AND THEY LEVERAGED OVER \$44 MILLION. FROM OUR 2023 LOANS, 140.5 JOBS HAVE BEEN RETAINED AND 253.5 NEW JOBS HAVE BEEN CREATED.
